Dues:

The annual dues for those who are elected to membership during the months of October, November and December shall be valid until December 31st of the following calendar year.

There will be a one-time administrative fee for \$10.00 for each application for membership.

Single - \$25.00 per year + one-time administration fee of \$10.00 = \$35.00

Family (Two adults in household): \$35.00 per year + one-time administration fee of \$10.00 = \$45.00

Code of Ethics

In keeping with my (our) dedication to promote high ideals among purebred dog owners, exhibitors, fanciers, and breeders and to strive for continual improvement of all breeds, I acknowledge and agree to the following principals:

1. As an owner or exhibitor of purebred dogs, I will:
 - a. Practice the principles of good sportsmanship and abide by the rules of the American Kennel Club in all my activities involving purebred dogs.
 - b. Be alert to the needs of the novice owner or exhibitor and assist him/her whenever I can.
 - c. Support humane treatment of all dogs and do my utmost to correct injustices that come to my attention.
2. If I choose to have a litter, I will:
 - a. Strive to become knowledgeable of good breeding procedures and use AKC approved breed standards as my guide to improve the breed. Consistent with this objective, I will make an effort to become knowledgeable of hereditary defects and their mode of inheritance. I will strive to eliminate them from my breeding stock.
 - b. Not sell any puppy or adult dog without true representation to the purchaser nor use misleading untruthful statements in selling or advertising.
 - c. Explain to all prospective buyers the advantages and disadvantages of my breed(s). Furthermore, I will not sell, donate or otherwise place a purebred dog into any home or environment when I have reason to believe this will not be in the best interests of both the new owner and the dog.
 - d. Nor knowingly sell or donate any purebred puppy or adult dog to raffles, auctions, dog wholesalers or retailers on either outright or consignment basis nor to any person, agent thereof, whose objective is the production of purebred dogs for these purposes. Further, I will not knowingly permit a dog I own, in whole, or in part, to be used at stud to any bitch when I have reason to believe any product of this mating might be disposed in the manner designated above. I will not knowingly allow a dog I own or sell to be used for laboratory testing.

Being in favor and willing to support the Code of Ethics, the objectives as herein set forth, and the Constitution and By-laws of the Sierra-Tuolumne Kennel Club, Inc., the precepts of the conduct and general business as set forth in the Policy Manual and to uphold the rules and regulations of the American Kennel Club, I (we) do hereby apply for membership in the Sierra-Tuolumne Kennel Club, Inc.
